Non-title Rebuilt or Rebuildable	Damage Check	The vehicle was a salvaged vehicle that was refurbished with new or used parts. An affidavit of repair from the rebuilder or individual making the repairs, stating what repairs were made to the vehicle and that the vehicle is now rebuilt and road operable, may be required to obtain a rebuilt/rebuildable title. These vehicles must also pass a state safety inspection before being allowed back on the road. These records were reported by the auction or salvage auction when the damage was discovered by Auction inspections or when the sellers disclosed or the auction discovered flood damage history from the DMV and/or insurance company records.
